DCC Highways provided the following response to all 3 above: Thank you for taking the time to submit this report. What action has been taken?

This location is currently under a yellow weather warning for wind and rain. The recent storm and high water levels have highlighted some challenges, as the volumes our assets are experiencing exceed their design capacity.

It is important to note that highway assets and drainage systems are designed to manage water falling on the highway, not to protect private properties. This is a common misconception. Landowners are responsible for safeguarding their own properties against water ingress. This may include installing appropriate drainage systems, using water-resistant materials, ensuring the property is graded to direct water away from buildings, to name a few.

We will respond to highway flooding causing an obstruction if, 24 hours after the rain has stopped, any of the following conditions apply:

- The road is impassable
- Water forces vehicles, cyclists, or pedestrians more than one metre away from the nearside of the road
- Vehicles are required to cross the centreline marking.

While we appreciate that blocked gullies can cause inconvenience to adjacent properties, in this instance none of the above conditions are present. Therefore, we are unable to attend on a reactive basis. Please be assured that the gullies will be cleaned as part of our annual programme.
